ORDINANCE NO. 07-702-2025

AN ORDINANCE AMENDING ORDINANCE NO. 09-432-2016 PARTICULARLY SECTION 6 (F) AND (H) LOWERING THE REQUIRED FINAL GRADE FOR EDUCATIONAL ASSISTANCE QUALIFICATION AND RETENTION FROM 82% TO 80% AND **ENROLLMENT** GRANTEE/SCHOLAR SHALL BE WITHIN THE REGION (REGION IX) WITH CORRESPONDING MOA PROMOTE INCLUSIVE AND EQUITABLE ACCESS TO EDUCATION.

WHEREAS, Education is a fundamental right and plays a vital role in personal and community development;

WHEREAS, the current grade requirement is 82% for educational assistance qualification or retention may unintentionally exclude deserving but financially challenged students who strive academically despite difficult circumstances;

WHEREAS, adjusting the final grade requirement to 80% will provide fairer access to Educational Assistance opportunities and recognize varying academic conditions without compromising the standard of excellence;

WHEREAS, the Scholarship Program/Educational Assistance shall be within the region (Region IX) and a corresponding Memorandum of Agreement (MOA) shall be executed for the purpose;

NOW THEREFORE, be it ordained by the Sangguniang Bayan of Ipil, Zamboanga Sibugay in session assembled that;

SECTION 1. LOWERING OF REQUIRED FINAL GRADE.

The minimum required general average for educational assistance qualification or renewal shall be lowered from 82% to 80% starting school year 2025-2026.

SECTION 2. SCOPE AND COVERAGE.

This Ordinance shall apply to all existing and incoming student beneficiaries of LGU Ipil, Zamboanga Sibugay Scholarship Program/Educational Assistance and extend the said program in schools within Region IX with a corresponding Memorandum of Agreement (MOA).

SECTION 3. MONITORING AND EVALUATION.

The Scholarship committee/Board shall monitor the performance of Scholars and assess the impact of this ordinance annually to ensure continued academic program sustainability.

SECTION 4. REPEALING.

All ordinances, rules or provisions inconsistent with this ordinance are hereby repealed or modified accordingly.

SECTION 5. EFFECTIVITY.

This ordinance shall take effect immediately upon approval by the Municipal Mayor.
