ORDINANCE NO. 07-703-2025

AN ORDINANCE TEMPORARILY CLOSING CERTAIN
STREETS IN IPIL, ZAMBOANGA SIBUGAY DURING THE
CONGRESSIONAL NIGHT: "HAPI-HAPI NIGHT WITH
CONG. MARLY" EVENT, FROM 5:00PM TO 5:00AM ON
JULY 18, 2025 IN CONNECTION WITH THE
CELEBRATION OF THE 76TH ARAW NG IPIL.

WHEREAS, the 76th Araw ng Ipil is a significant event
celebrated annually in Ipil, Zamboanga Sibugay;

WHEREAS, Congresswoman Doc Marly Hofer-Hasim will host
the Congressional Night: "Hapi-Hapi Night with Cong. Marly"
on July 18, 2025, at the Ipil Central Sports Complex;

WHEREAS, the successful conduct of said event requires the
temporary closure of certain streets to ensure public safety,
efficient traffic management, and the smooth flow of activities;

NOW, THEREFORE, BE IT ORDAINED BY THE
SANGGUNIANG BAYAN OF IPIL, ZAMBOANGA
SIBUGAY:

SECTION 1. Temporary Closure of Streets. The following
streets in Ipil, Zamboanga Sibugay are hereby temporarily closed
to vehicular traffic on July 18, 2025:

- G. Ferraris Street
- Magsaysay Street
- Mayor Generoso Sugang Avenue
- San Juan Street

SECTION 2. Purpose of Closure. The temporary closure of the
aforementioned streets is necessary for the preparation, conduct,
and security of the "Hapi-Hapi Night with Cong Marly" event,
ensuring the safety and convenience of participants and
spectators.

SECTION 3. Traffic Management. The Ipil Municipal Police
Station shall implement a comprehensive traffic management
plan to minimize disruption to traffic flow and ensure the safety
of motorists and pedestrians during the closure. Clear signage
and alternative routes will be provided.

SECTION 4. Enforcement. The Ipil Municipal Police Station and

other concerned agencies are hereby authorized to enforce this ordinance to ensure proper coordination, crowd control, and public safety throughout the activity.

SECTION 5. Effectivity Clause. This ordinance shall take effect immediately upon approval by the Municipal Mayor.


