AN ORDINANCE DECLARING A ONE WAY TRAFFIC
SCHEME ALONG MAGSAYSAY ST. FROM MAYOR
GENEROSO AVENUE TO G. FERRARIS ST. BEING
IMPLEMENTED DURING THE PERIOD OF AUGUST 5,
2025 TO JANUARY 4, 2026, ONLY ON WEEKENDS AND
SHIFTS DURING THE HOURS OF 6:30AM TO 8:00AM AND
3:00PM TO 5:00PM.

WHEREAS, the Ipil Central School, especially the Special
Education (SPED), being a recipient of a school building, is now
constructing a building in the area;

WHEREAS, the duration of the construction entails a longer
period and estimated to be completed within six (6) months;

WHEREAS, to minimize disruption of traffic flow and ensure
the safety of the school children, motorists and pedestrians
during the aforementioned time, there is a need to implement a
one way traffic scheme to this effect;

NOW THEREFORE, be it ordained by the Sangguniang Bayan
in session assembled that:

SECTION 1. PURPOSE OF THE ONE WAY TRAFFIC
SCHEME

A one way traffic scheme is hereby declared along Magsaysay
Street from Mayor Generoso Sugcang Avenue to G. Ferraris St.,
Brgy. Poblacion during the period of August 5, 2025 to January
4, 2026 only on weekdays and strictly during the hours of
6:30am to 8:00am and 3:00pm to 5:00pm to ease and control the
traffic during the construction of the school building.

SECTION 2. TRAFFIC MANAGEMENT. Shall be implemented
to minimize disruption to traffic flow and ensure the safety of
school children, motorists, and pedestrians during the specified
hours/time; that clear signage and alternative routes will be
provided.

SECTION 3. ENFORCEMENT


That the Municipality of Ipil Traffic Safety Operation & Management (MITSOM) in coordination with the Barangay Council of Poblacion and the Ipil PNP be authorized to enforce this ordinance to ensure proper coordination, crowd control, and public safety throughout the duration.

SECTION 4. EFFECTIVITY

This ordinance shall take effect upon approval of the Municipal Mayor.
