ORDINANCE NO. 2-696-2025

AN ORDINANCE RENAMING THE POSITION OF ECOSYSTEM MANAGEMENT SPECIALIST I, SALARY GRADE 11/1 IN THE MUNICIPAL ENVIRONMENT & NATURAL RESOURCES OFFICE (MENRO) TO ADMINISTRATIVE ASSISTANT IV (BOOKBINDER IV), SALARY GRADE 10/1, THIS MUNICIPALITY, AND PROVIDING FUNDS THEREOF.

WHEREAS, Section 76, of Republic Act No. 7160, provides that every local government Unit shall design and implement its own organizational structure and staffing pattern taking into consideration its service requirement and financial capability, subject to minimum standard and guidelines prescribed by the Civil Service Commission;

WHEREAS, pursuant to Section 447 (a)(i)(viii) of RA 7160, otherwise known as the Local Government Code of 1991, the Sangguniang Bayan shall determine the positions, salaries, wages, allowances and other emoluments and benefits of officials and employees paid wholly, or mainly from municipal funds and provide for expenditures necessary for the proper conduct of programs, services and activities of the Municipal Government;

WHEREAS, Section 325 paragraph f of the Local Government Code of 1991 allows the change in name of position, which provision states:

*“ SEC. 325. General Limitations. – The use of the provincial, city, and municipal funds shall be subject to the following limitations:*

*xxx*

*(f) No changes in designation or nomenclature of positions resulting in a promotion or demotion in rank or increase or decrease in compensation shall be allowed, except when the position is actually vacant, and the filling of such position shall be strictly made in accordance with the civil service law, rules and regulations;*

*xxx”*

WHEREAS, the Committee on Appropriation acknowledges the 2<sup>nd</sup> Indorsement from the Office of the Municipal Budget Officer, Ms. Lourelyn Y. Gallemitt of which said request has been referred to their office for technical assistance and as to funding allocation;



SECTION 1. TITLE. An Ordinance RENAMING THE POSITION OF ECOSYSTEM MANAGEMENT SPECIALIST I, SALARY GRADE 11/1 IN THE MUNICIPAL ENVIRONMENT AND NATURAL RESOURCES OFFICE (MENRO) TO ADMINISTRATIVE ASSISTANT IV (BOOKBINDER IV), SALARY GRADE 10/1, THIS MUNICIPALITY, AND PROVIDING FUNDS THEREOF.

SECTION 2. QUALIFICATION. As stated in the Qualification Standard of the Civil Service Commission, the person who shall be considered and appointed as Administrative Assistant IV (Bookbinder IV) Salary Grade 10/1 must possess of the following qualification standards, to wit:

Education	-	Elementary School Graduate
Training	-	8 hours of relevant training
Experience	-	2 years of relevant experience
Eligibility	-	None Required (MC 11, s. 96 – Cat. III)

SECTION 3. DUTIES, FUNCTIONS AND RESPONSIBILITIES.

80% - Administrative Assistant (Bookbinder IV)

20% - Does other related functions and duties as maybe prescribed/assigned

100% by the laws and ordinances or by the Supervisor

SECTION 4. SOURCE OF FUNDS. The appropriation for salaries and other benefits of the aforementioned position will be source out from the unfunded positions of this Municipality for Calendar Year 2025;

SECTION 5. SEPARABILITY CLAUSE. Any section or provisions of this ordinance which may be declared unlawful or unconstitutional shall not affect the other sections or provisions hereof.

SECTION 6. REPEALING CLAUSE. All ordinances, resolutions of local effect that are inconsistent with the ordinance are hereby modified, superseded or repealed accordingly.

SECTION 7. EFFECTIVITY. That this Ordinance shall take effect upon approval by the Municipal Mayor.
