RESOLUTION NO. 03-878-2010

A RESOLUTION DECLARING THE MUNICIPALITY OF IPIL IN CONSONANCE WITH THE ACTION OF THE NATIONAL GOVERNMENT IN STATE OF CALAMITY AND ALL OTHER BARANGAYS IN IPIL, ZAMBOANGA SIBUGAY.

WHEREAS, on March 11, 2010 no less than the President, Her Excellency President Gloria Macapagal-Arroyo, has declared state of calamity due to El Niño phenomenon, electricity crisis, water crisis, damage to agricultural crops and livestock are the most greatly affected;

WHEREAS, the use of calamity funds both the national government and local government are authorized to address this calamity situation;

WHEREAS, the municipality of Ipil is among the municipalities in Mindanao that is greatly affected, it is more than apparent that electricity shortage resulting to several hours of brownout has affected the economy of the town;

WHEREAS, the present situation has likewise worsened the perennial problem of water shortage in our municipality, even the source and the needs for potable water rose to a very alarming level. Livestock, crops and other agricultural produce must be given utmost attention if only to address security with the El Niño phenomenon;

NOW THEREFORE, on motion presented by SB Eleanor Sardual, duly seconded by SB Perfecto Guinosao, it was;

RESOLVED, as it is hereby resolved, to declare the Municipality of Ipil in consonance with the action of the national government in state of calamity and all other barangays in Ipil, Zamboanga Sibugay.
