A RESOLUTION APPROVING THE MEMORANDUM OF AGREEMENT (MOA) AND AUTHORIZING THE MUNICIPAL MAYOR, RAMSES TROY D. OLEGARIO, TO ENTER INTO & SIGN THE SAME IN BEHALF OF LGU IPIL, ZAMBOANGA SIBUGAY WITH IPIL HEIGHTS, REPRESENTED BY ITS BARANGAY CAPTAIN, IAN CHRISTOPHER A. ALBRETCH, FOR THE IMPLEMENTATION OF BARANGAY IMPACT PROJECT.

WHEREAS, forwarded to this august body is the urgent request of Atty. Rey Andre C. Olegario, Municipal Administrator & OIC Municipal Mayor dated August 8, 2025 for approval of the Memorandum of Agreement (MOA) for the implementation of barangay impact project in the amount of Two Hundred Thousand Pesos (P200,000);
