RESOLUTION NO. 08-067-2025

A RESOLUTION ADOPTING THE COMMITTEE REPORT NO. 071 OF THE COMMITTEE ON RULES, RESOLUTIONS ORDINANCES CONCERNING THE REVENUE CODE OF MAGDAUP, THIS MUNICIPALITY.

WHEREAS, the Committee on Rules, Resolutions & Ordinances take notice of the reglementary period of review on all barangay ordinances, the fact that the said ordinance was submitted last April 2025 and was subsequently referred to the previous committee chairman on rules, however, there was no action made:

WHEREAS, citing the provision of RA 7160 on the review of barangay ordinances, and when the SB fails to act within the said period of review, the ordinance is declared approved by operation of law;

WHEREAS, the committee then wishes to return the said Revenue Code for lack of jurisdiction over the enforced ordinance of the barangay, hence, recommend for adoption and acceptance;

NOW THEREFORE, on motion of SB Alberto A. Alcoriza, Jr. and duly seconded by SB Joel D. Ebol, it was;

RESOLVED, as it is hereby resolved, to adopt the Committee Report No. 071 of the Committee on Rules, Resolutions & Ordinances concerning the Barangay Revenue Code of Magdaup, this municipality.
