EXCERPTS FROM THE MINUTES TAKEN DURING THE 9<sup>TH</sup> REGULAR SESSION OF THE SANGGUNIANG BAYAN OF IPIL, ZAMBOANGA SIBUGAY HELD AT ITS SESSION HALL ON AUGUST 27, 2025 AT 9:00 A.M.

RESOLUTION NO. 08-072-2025

A RESOLUTION RESPECTFULLY URGING THE MUNICIPAL MAYOR, HONORABLE RAMSES TROY D. OLEGARIO THROUGH THE OFFICE OF THE MUNICIPAL ECONOMIC ENTERPRISE AND DEVELOPMENT OFFICE (MEEDO) TO INITIATE TRAINING PROGRAMS FOR INDIVIDUALS FROM THE 28 BARANGAYS TO BECOME PROFICIENT BUTCHERS FOR THE IPIL ABBATOIR, OF THIS MUNICIPALITY.

WHEREAS, The Local Government Code (R.A. 7160) provides Local Government Units (LGUs) with the authority to oversee the administration of slaughterhouses and meat inspection, However, the responsibility for training butchers is delineated in the Meat Inspection Code of the Philippines (R.A. 9296) as well as the regulations set forth by the National Meat Inspection Service (NMIS), these regulations require butchers to undergo comprehensive training and obtain necessary licensing to ensure proper meat handling practices while operating within licensed establishments, In turn, LGUs enforce these national standards through local ordinances, guaranteeing that butchers receive the required training and certification;

WHEREAS, the local government's slaughterhouse serves as a vital component of economic initiatives overseen by the Municipal Economic Enterprise Development Office, generating a monthly revenue of P3.3 Million Pesos;

WHEREAS, since the Ipil Abattoir's operations began, the staff of butchers and slaughterers has mostly been the same and lost its effectiveness;

WHEREAS, the actions of the abattoir staff have led to significant challenges, their lack of diligence has resulted in meat deliveries that do not meet the operational requirements of the Ipil Central Market, thereby adversely affecting its performance;

WHEREAS, to maintain operational efficacy, it is imperative that meat be delivered by 4:30 in the morning, as the market commences business at 5:00 a.m;

WHEREAS, the integrity of the Ipil Central Market's operations is critical, as it constitutes a primary source of income for the Local Government Unit;



WHEREAS, the ongoing shortage of staff and the negative attitudes of butchers in slaughterhouse underline the pressing need for training initiatives for potential butchers from the 28 barangays of this municipality;

WHEREAS, training new personnel will foster improved logistical operations and enhance relationships with vendors, ultimately leading to greater overall operational effectiveness;

WHEREAS, training ensures that butchers and slaughterhouse staff follow proper hygienic practices to prevent meat from becoming contaminated, reducing the risk of blood-borne illnesses;

NOW THEREFORE, on motion of Hon. Joel D. Ebol, duly seconded by Hon. Alhapid E. Mohammad, it was;

RESOLVED, as it is hereby resolved, respectfully urging the Municipal Mayor honorable Ramses Troy D. Olegario through the Office of the Municipal Economic Enterprise Development (MEEDO) to initiate training programs for individuals from the 28 barangays to become proficient butchers for the Ipil Abattoir of this municipality.

RESOLVED FURTHER, the training program is set to commence without delay.


