A RESOLUTION ENDORSING TO THE MUNICIPAL MAYOR, HONORABLE RAMSES TROY D. OLEGARIO, HONORABLE ANAMEL C. OLEGARIO, MUNICIPAL VICE MAYOR AND MEMBERS OF THE SANGGUNIANG BAYAN THE BARANGAY RESOLUTION NO. 07-029-2024 OF BANGKEROHAN FOR THE POSSIBLE INCLUSION OF FUNDING FOR CY 2026 FOR THE RENOVATION OF THE DILAPIDATED DAY CARE CENTER AT PUROK URANUS, BANGKEROHAN, IPIL, ZAMBOANGA SIBUGAY.

WHEREAS, the Day Care Center at Purok Uranus, Barangay Bangkerohan, of this municipality, was constructed several years ago using temporary and light materials;

WHEREAS, the said Day Care Center has now become dilapidated, unsafe and inadequate for the use of children and teachers, thus, affecting the quality of early childhood care and education in the community;

WHEREAS, there is an urgent need for the renovation and improvement of the said Day Care Center to ensure the safety, comfort and proper learning environment of the children;

NOW THEREFORE, on motion of Hon. Elias S. Dangpalan, duly seconded by Hon. Alhapid E. Mohammad, it was;

RESOLVED, as it is hereby resolved, endorsing to the Municipal Mayor, Honorable Ramses Troy D. Olegario, Honorable Anamel C. Olegario, Municipal Vice Mayor and Members of the Sangguniang Bayan, the Barangay Resolution No. 07-029-2024 of Bangkerohan for possible inclusion of funding for CY 2026 for the renovation of the dilapidated Day Care Center at Purok Uranus, Bangkerohan, Ipil, Zamboanga Sibugay.
